The number of segments indicates the generation. For example, 1.2.3 is the third child of 1.2 who is the second child of 1.0. Spouses are identified with a suffix of "-n" where n is the number of the marriage; for example, 1.2.3-1 is the first spouse of 1.2.3.

			HATTIE FRANKLIN BORN 1849 DIED 1897 AT REST Hattie was believed by some to be his second wife, but I have found no evidence for this. I believe her to be daughter Harriet. Robert S. Latimer believes she was the wife of Philip's son Philip, but this man lived in California as early as 1860 and died there unmarried in 1899. There is more discussion of her identity in the entry for Henriette Dorey. Another mystery is why Philip's early children were baptized in an Anglican church (the last in 1843) and the later children were baptized in a Catholic church (beginning in 1845). I ascribe children William and Chester Leet to Philip because of their naming on the stained glass window. It may be that William was really George William Dorey (son of George and Charlotte) and Chester Leet was Ralph Chester Leet Dorey (son of Henry James Lafford Dorey and Janet Robertson) b. 1897. Philip Cyrus Dorey is my ggg grandfather.

In summer 1786 Margaret's grandfather Andrew Leete moved his wife and six children from CT to Guysborough, Nova Scotia. He was one of the 18 original settlers of the Hallowell Grant. (In 1765 Benjamin Hallowell, Sr., Comptroller of the Port of Boston, received a grant of 20,000 acres on Chedabucto Harbor in what is now Guysborough County. At the end of the American Revolution, lands were granted to soldiers of disbanded regiments and to settlers from former American colonies who had remained loyal to the British crown.) Margaret's father was born with his surname spelled Leete, the final "e" was dropped when the family moved to Nova Scotia. Margaret, born in NS, was named Leet. Grandfather Andrew settled on 150 acres in Guysborough Intervale on the banks of the Milford Haven River. In 1871 Margaret lived with son Andrew Cyrus in Arichat. (Andrew died in Colorado in 1913.) Margaret's death is believed to be about 1875. No burial record found. Frustration continues. A 63-year old Margaret Dorey took a boat, Steamer Alhambra, to Boston, arriving 9-29-1873. This is classed as an act of immigration. On 7-3-2018 I found a New York death certificate #928 for 84-year old Margaret Darey. She died 1-7-1893 New York City, NY. This woman may or may not be my ggg grandmother.

Daughter? First of all, Hattie is a common nickname for Harriet. Some researchers believe Hattie to have been a second wife of Philip's, but there is no evidence for this aside from the tombstone itself. I believe Hattie to be the daughter who was baptized as Henriette, which is why I report here that Harriet died in 1897. Family genealogist Robert S. Latimer in his Latimer Family History states that "Philip married Hattie Franklin," Philip being #1.2. This was repeated in Janvrin's Island, 200 Years to Celebrate. That claim seems unlikely because Philip Dorey the son lived in California from at least 1860 until his death in 1899 as an unmarried man. Stay tuned. I think both men were wrong, by assuming a connection between Harriet and Philip based on the gravestone; there was a relationship, but it was father and daughter, not man and wife. The 1897 burial record was transcribed as "Mrs. Franklin?" and cause of death as "Drowned while bathing near the house; as a good swimmer supposed to have taken a fit or cramps in the water." This record, aside from the troublesome question mark, suggests that Hattie was not Mrs. Dorey. Regrettably, no Mr. Franklin has been identified.
